RULES AND REGULATIONS

- Entry fee STRICTLY NON REFUNDABLE.
- System of Play The latest FIDE Rules in force shall apply and the SWISS system will be followed.
- Mode of Tournament Total Nine rounds shall be played.
- The Break: In case of a tie, the latest FIDE Rules shall come in to effect. The Cash prizes will not be shared.
- Time Contral 30 Minutes each with 30 seconds increment from move number one.
- Default Time (Walk Over Time): The Default time will be 15 minutes.
- Electronic Devices all electronic items including wrist watches (all type of watches) will not be allowed in the tournament hall.
- · Eligibility:
- All Rated & Unrated Players:
- Only players who have not crossed the FIDE Rating of 1599 in the past 36 months prior to the start of the Event are eligible to participate.
- Players who finished 1st or 2nd in any rating restricted tournament are not eligible to play in any rating restricted tournament for 1 year from the date of such achievement.
- Players who is found guilty (as a above rules) at any stage of the tournament will be withdrawn from the tournament & entry fees shall not be refunded.
- AICF Players Registration AICF registration is compulsory. AICF Registration fee is Rs. 250/- for the year 2022-2023. As per latest AICF regulation dated: 31-07-2017. It is informed that from 1st September, 2017. All AICF player registrations will be accepted only through online. Player's registration should be done well before the start of event.
- Existing Registration on For existing players please go to your player page in https://prs.aicf.in/players and click on extend membership.
- New (Fresh) Registration https;//prs.aicf.in/new-register For fresh AICF player registration, players are requested to keep their scanned passport size photograph and birth certificate and a valid email address (Unique) not used by any other person /player for AICF player registration. Note: Only passport size (less than 1 MB) photograph in jpeq format should be uploaded.
- Protest Protests if any, against the decision of the Chief Arbiter shall be made in writing with protest free fo Rs. 1000/- within 15 minutes after completion of the game to comittee. The protest fee will be refunded if the appeal is uphled.
- Appeals Committee Before the commencement of the Tournament, appeals committee comprising of five members, will be formed from the senior participants present in the players meeting. The appeals committee decision will be final and binding on all the players concerned.
- Withdrawals A player may withdraw at any stage of the event, after informing the cheif arbiter in writing.
- Player qualified for more than one prize will be considered only for higher prize.
